MEMBERSHIP QUALIFICATIONS

SECTION (3) – ACTIVE MEMBERSHIP

Any person engages in the practice or teaching of geosciences may apply for Active Membership provided the applicant holds a Bachelor's Degree in geosciences from a College of acceptable standards and in addition, has had three (3) years of experience in the practice or teaching of geosciences. Credit for experience can be counted as follows:

- **Master's Degree (1) Year**
- **Doctor's Degree (2) Years**

The Executive Committee may waive degree or current professional activity requirements if in its judgment an applicant has adequate professional experience and has attained standing in the profession.

SECTION (5) – JUNIORS

Any graduate with a major in geosciences from a College of acceptable academic standards may apply for junior membership provided that:

- a) The Applicant is engaged in Petroleum exploration or research; Or**
- b) The Applicant is enrolled as a Graduate student in geosciences; Or**
- c) The Applicant is engaged in teaching Geosciences.**

SECTION (6) – STUDENTS

Any student majoring in geosciences at a College of acceptable academic standards may apply for student membership.

SECTION (7) – ASSOCIATES

Any Person not Qualified for any other class of membership and who is graduate of a College of acceptable academic standards whose employment is associated with geosciences, may apply for election as an Associate. The Executive Committee may waive degree requirements, if in its judgment an applicant has adequate professional experience, and has attained professional standing.
